# Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that the Ministry of Ports, Shipping and Waterways vide email dated 15.07.2025 has informed about the letter no. 01/03/2024-EO(ACC) dated 12.07.2025 from Secretariat of the Appointments Committee of the Cabinet, Department of Personnel & Training, wherein it is communicated that the Appointments Committee of the Cabinet (ACC) has approved the following proposals of the Ministry of Ports, Shipping and Waterways:-

- (i) Ex-post facto approval for entrustment of additional charge of the post of Chairman & Managing Director (CMD), Shipping Corporation of India Land and Assets Limited (SCILAL) to Capt. B.K. Tyagi, CMD, Shipping Corporation of India (SCI) w.e.f. 25.01.2024 to 31.12.2025, or till assumption of charge of the post by the regular incumbent, or until further orders, whichever is the earliest.
- (ii) Ex-post facto approval for regularization of additional charge of the post of Director (Operations), SCILAL entrusted to Shri Manjit Singh Saini, Director (Personnel & Administration), SCI w.e.f. 25.01.2024 to 31.01.2025, i.e. till the date of his superannuation.

Informatively, Shri Manjit Singh Saini superannuated from SCI on 31.01.2025. Consequently, he also ceased to be a Director on the Board of SCILAL with effect from 01.02.2025.
